During GA, the AUUA will have a booth in the Exhibit Hall. This booth is a place for Administrators at GA to gather with other Administrators, a place for people to get more information about our organization and what we provide, and a place for AUUA members to introduce themselves to other UUs who have no idea we even exist. #### THE BENEFITS OF AUUA MEMBERSHIP

A few reminders about membership:

- Membership in AUUA is open to all administrators in UU congregations and those serving in an administrative capacity at the UUA or UU-affiliated organization. (Not all AUUA members are Unitarian Universalist or a member of a UU congregation.) You need to renew your membership annually.
- Additional administrative staff within your church, regional office, or UUA department receive a 50% discount off their AUUA membership fee after one fully paid AUUA membership this discount is available for up to five additional staff members.
